- ✓ Self-nominations are permitted and encouraged.
- Nominations must be submitted online. Deadline to submit your nomination is 8:00 PM EST on December 2, 2019.
- ✓ Point form is permitted and encouraged.
- Please note, once you have submitted the nomination form, you will not be able to make any changes or edits to your submission.
- The CSTA reserves the right to transfer nominations into the appropriate category should it be deemed ineligible for the category submitted.

The CSTA International Sport Event of the Year Award presented by CBC Sports recognizes the overall success of an outstanding international sport event held in Canada in 2019. The Events Rights Holder **must be an International governing body/entity** and a Canadian community bid against other International communities and won the right to host the event in Canada. The event's international broadcasting/streaming reach will be a significant part of the evaluation criteria.

If you submit an incomplete form, you will not be able to go back and add or change any of the information on the online form. To assist in your preparation – the point totals used in the adjudication have been indicated in the relevant sections.
